#### 1. Appointment

In accordance with the express terms of the Default Provisions set forth in the Notice attached to this Special Power of Attorney document having been communicated to the Office of the United States Attorney General by facsimile transmission on Thursday, January 29, 2015, at 12:00 a.m. EST [Wednesday, January 28, 2015, at 9:00 p.m. PST], to number (202) 307-6777, the United States Attorney General, by virtue of said Office authorizes Bradley Christopher Stark to sign this document on behalf of the United State Attorney General in a representative capacity and said signature is valid, irrevocable, and enforceable to the same extent as if the United States Attorney General signed and executed this Irrevocable Special Power of Attorney Coupled with Interest. The authorizing language of the Default Provision is fully and accurately recited hereinbelow:

SELF-EXECUTING SPECIAL POWER OF ATTORNEY COUPLED WITH INTEREST. To facilitate your strict compliance with the terms of the Contract No. 917092-Bl/USAG; the Award; the enclosed Offer of Settlement and Stipulation Agreement; and the enforcement thereof, by your default you give, by remaining silent, irrevocable special power of attorney to Claimants or their retained Counsel to sign and execute for you and on behalf of the Respondents regarding the enforcement of your obligations under Contract No. 917092-Bl/USAG; the Award; and the Offer of Settlement and Stipulation Agreement. In that event, you instruct and authorize the Claimants or their retained Counsel to execute your signature and/or the Respondents signature(s) in representative capacity on a Self-Executing Irrevocable Power of Attorney document with respect to these proceedings and any and all matters related thereto.

THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that I, Eric H. Holder, Jr., by virtue of my Office as the United States Attorney General, referred to herein as "Principal", my place of business being located at the United States Department of Justice, 950 Pennsylvania Avenue, NW, in the city of Washington, District of Columbia, designate Bradley Christopher Stark, of State Route 716, city of Ashland, State of Kentucky, [legal residence at 2096 Northshore Drive, Unit F, city of Chula Vista, state of California], to serve as my Agent and Attorney in Fact, referred to herein as "Agent", to act in my name ex officio and for my benefit and to exercise the powers set forth below.

#### 2. Effective Date

This Power of Attorney is self-executing and becomes effective upon signing of this document and remains in effect through satisfaction of all obligations and settlement of all claims as to Contract No. 917092-B1/USAG; the Arbitration Award; and the Offer of Settlement and Stipulation Agreement, including any and all necessary matters directly relating thereto.

#### 3. Construction

This instrument is to be construed and interpreted as a special power of attorney coupled with interest. The enumeration of specific items, acts,

rights, or powers herein does limit the powers granted to my agent.

### 4. Scope of Authority

My agent shall have the authority customarily granted in a Power of Attorney Coupled with Interest, limited to the following purposes:

- a. Settle, prosecute, defend, and/or initiate all claims and litigation strictly limited to the enforcement of obligations under Contract No. 917092-B1/USAG; the arbitration Award; the Offer of Settlement and Stipulation Agreement; and/or any ancillary matters directly related thereto and no other; and
- b. Sign and execute any and all contracts, agreements, settlements, and stipulations directly relating to the enforcement of the obligations under Contract No. 917092-B1/USAG; the arbitration Award; the Offer of Settlement and Stipulation Agreement; and/or any and all ancillary matters directly related thereto and no other.

#### Revocation

This special power of attorney coupled with interest is irrevocable.

I hereby ratify and confirm all that my agent shall lawfully do or cause to be done by this special power of attorney coupled with interest and the rights and powers granted herein.

# 7. Indemnification of Acts of Agent while Carrying out Authority

I hereby bind myself and my Office to indemnify my agent against any and all claims, demands, losses, damages, actions, and causes of action, including expenses, costs, and reasonable agent's fees which my agent at any time may sustain or incur in connection with his carrying out the authority granted him in this special power of attorney coupled with interest.
